# Eligibility of applicants:

- 1. Thai national or persons holding other nationalities.
- 2. Doctoral degree in Nutrition, Public Health, Epidemiology, Health Sciences, or other related disciplines.
- Experience in community nutrition, population-based nutrition, epidemiological research, or research in related disciplines will be given particular weight in assessing an applicant's strength.
- 4. Experience in teaching/training in graduate courses, especially in the area of expertise.
- 5. Computer software usage skills.
- **6.** High proficiency in English (spoken, written, reading, and listening comprehension). Proof of English proficiency in terms of either TOEFL or IELTS is appreciated. A minimum score of English proficiency test is as follows:
  - IELTS (Academic Module) ≥ 6 or
  - TOEFL IBT (Internet Based) ≥ 79 or
  - TOEFL- ITP ≥ 550 or
  - TOEFL- CBT ≥ 213
